Take-Home-Points

- Private equity is estimated to control over 50% of emergency department visits and growing
 rapidly. It is the most egregious form of profiteering at the expense of patients the world has ever
 seen. While emergency medicine may be most affected, this now extends to nearly all specialties.
- Physicians' first priority is to our patients' health, wellbeing, and safety. The first priority of
 corporations is to their shareholders. State Corporate Practice of Medicine Laws (CPOM) are
 designed to prevent this but are rarely enforced.
- Heavily indebted young physicians have no choice but to work for corporate private equity owned staffing groups and have no control or knowledge about what is billed to patients in their name, and are required to sign away their rights to due process, silencing would-be whistleblowers.
- Corporate interests have infiltrated our specialty societies. The American College of Emergency
 Physicians has left patients and emergency physicians behind for over 30 years, being unable to
 best represent and advocate for our patients and for patient care by standing up to the corporate
 practice of medicine.
- Take Medicine Back PBLLC, and TakeEMBack represents a growing grassroots coalition to end
 the corporate practice of medicine so that physicians can freely advocate for patients, with or
 without our largest specialty society (ACEP) at great personal and professional risk to all
 involved.
